At the outset the Member Secretary welcomed the Hon'ble IPH Minister & other members for the meeting.

Thereafter, discussion on agenda items followed as under:

ITEM No. I Procurement of D.I. Pipes :

The committee considered and approved the online tender case of D.I. Pipes , opened on 22.05.2017, and decided to procure the approved quantity of 68224 Rmt. of D.I. Pipes of various diameters Class K-7 from L-1 firms on the basis of diawise rates negotiated & finalized with the Firms.

ITEM No. II Procurement of G.I. Pipes Priority-I (Phase-II) & Priority-II for the year 2017-18:

After detailed discussion, the committee opined that due to change in the tax structure after implementation of GST and its possible implication in raw material rates, it would be appropriate to call fresh online tenders for 4631 MT quantity of Phase II of Priority-I & 7524 MT Priority-II quantity of GI Pipes.

The previous tenders for procurement of GI Pipes, based on old tax structure with validity up to 30.09.2017, shall be considered as cancelled accordingly.

ITEM No. III**Procurement of HDPE Pipes :**

The committee approved the total requirement of HDPE Pipes i.e. 9195 Rmt. of Fatehpur Division and decided to procure the same on HP Controller of Stores rate contract which is valid up to 31.03.2018 with GST amendment to be issued by the Controller of Stores.

ITEM NO.IV**Implication of GST on supply order of G.I. Pipes placed during June 2017:**

The committee examined and consented to the amendments issued by the department in supply orders placed on 12.06.2017. However, Additional Secretary (Law) suggested that future tenders should have provision to account for any changes in the tax structure during validity of tender. Chairperson desired that necessary condition should be incorporated in future NITs.

The committee approved the additional requirement of HDPE Pipes i.e. 55,023 Rmt. required by IPH division Kaza, Pooch & Nerwa and decided to procure the same on HP Controller of Stores rate contract which is valid up to 31.03.2018 with GST amendment to be issued by the Controller of Stores.


ITEM NO.II Procurement of G.I. Wire:-




