Engineer-in-Chief, I&PH Department, H.P. MINUTES OF 4<sup>th</sup> MEETING OF SCREENING COMMITTEE FOR THE YEAR 2017-18, HELD ON 16.03.2018 UNDER THE CHAIRMANSHIP OF HON'BLE I&PH MINISTER FOR PROCUREMENT OF GI/DI & HDPE PIPES.

At the outset the Member Secretary welcomed the Hon'ble IPH Minister & other members for the meeting.

Thereafter, discussion on agenda items followed as under:

### ITEM No. I

## Procurement of priority-II G.I. Pipes for the year 2017-18:

The Member Secretary explained in the meeting that the annual requirement of G.I. Pipes i.e. 19378 MT was approved by the screening committee in its 1st meeting and it was decided to procure pipes in three parts depending on availability of funds i.e. Priority- 1st (Phase-I&II) & Priority-2nd. The supply orders for phase-I of priority-I requirement i.e. 7223 MT of GI pipes were placed on 12.06.2017, thereafter as per decision taken in the 2<sup>nd</sup> meeting of Screening Committee, due to implication of GST fresh online tender for procurement of G.I. Pipes for Phase-II of Priority-I & Priority-II were called which were opened on 08.09.2017. The Screening committee in its \$1rd meeting approved the tender and decided to procure phase-II of Priority-I requirement i.e. 4631 MT G.I. Pipes keeping in view the availability of funds, supply orders for which were placed on 08.01.2018. Further Member Secretary explained that now the updated priority-II requirement of 7778 MT has been received from all zonal offices. The procurement of pipes for priority-II was delayed due to nonreceipt of 2nd installment of funds from Govt. of India under NRDWP. Since now funds under NRDWP for 2nd installment have been received so it is proposed to procure priority-II requirement of G.I. Pipes against tender already approved which is valid up to 31.10.2018.

After discussion, the committee considered and approved the priority-II requirement of G.I. Pipes. The committee further decided that priority-II requirement of G.I. Pipes i.e. 7778 MT be procured from L-1firms and L-2/L-3 firms or the matching rail head rates of L-1 firm on the basis of dia-wise rates negotiated & finalized with the firms against above tender. As per proposal of the department, the quantity to all the firms be allotted up to 3000 MT only for ensuring timely supply of pipes with in delivery period i.e. 60 Days.

## ITEM No. II Procurement of D.I. Pipes:

It was explained by the Member Secretary that fresh requirement of D.I. Pipes have been received from two divisions i.e. Ghumarwin & Keylong for their sewerage schemes for which required funds are available. Hence it is proposed to procure the DI Pipes against tender opened on 22.05.2017, rates of which are valid up to 30.06.2018.

The committee considered & approved the requirement of DI Pipes i.e. 14185 Rmt. and decided to procure the same from L-1 firms against above tender.

## ITEM No. III Procurement of HDPE Pipes:

Member secretary explained that for ongoing HIMCAD Projects under which CAD activities are to be under taken in cluster of minor irrigation schemes in the shape of pipes & field channels in the fields for which HDPE Pipes are urgently required. These pipes are to be laid in the fields after harvesting of Rabi Crops i.e. in the month of April to June 2018.

The committee approved the total requirement of HDPE Pipes i.e. 473888 Rmt. and further decided to procure the same from firm which are on HP Controller of Stores rate contract which is valid up to 31.03.2018.

# I ITEM NO.VI Ex-Post Facto approval for procurement of G.I. Pipes for Sarkaghat Division:

The Member Secretary explained that some urgent requirement of Sarkaghat Division i.e. 424 MT of G.I. Pipes of different diameters was received form Chief Engineer (Hamirpur Zone) which was incorporated in supply orders of phase-II of priority-I requirement placed on 08.01.2018.

After discussion, keeping in view the urgency, the committee granted the ex-post facto approval for 424 MT G.I. Pipes of Sarkaghat Division.

The meeting ended with a vote of thanks to and from the chair.
